## HORDHACA

Weerarka galmada, rabshada qoyska iyo dabagalada waa falal loogu talo galay inay cabsi geliso, dhibaateeyso, hoos u dhigto, sharaf disho, xukunka iyo maamusho qof kale. Haddii wax sidaan oo kale ay kugu dhaceen, qaladkaaga ma aheyn. Qofka midaan adiga kugu sameeyay ayaa leh qaladka; umaadan qalmin ama ma weydiisan.

### **Haddii aad aheyd dhibane dambi, xaq ayaad uleedahay.**

Warbixinta xigta waxaa loogu talo galay sida aasaaska jaheynta oo dhibanayaasha dambiga rabshada ee Gobolka Franklin. Weerarka galmada, rabshada qoyska iyo dabagalka waa dambiyada rabshada ee lagu sheegay buug-yaraha.

Dhibanayaasha dambiga inta badan way ka baqaan waxa ku dhacay iyaga. Waxaa laga yaabaa inaysan hubin sida nidaamka maxkamada u shaqeeyo, ama way ka cabsan karaan waxa iyaga ku dhacayo, qoyskooda, ama dambiilaha. Iyada oo kuwaa ay yihiin dareemo guud, **waxaa jiro meelo caawin loo aadi karo haddii aad aheyd dhibanaha weerarka galmada, rabshada qoyska ama dabagalka.**

Hay'adaha ku qoran buug-yaraha waxay la waaya arag yihiin la shaqeynta bulshooyin kala duwan. Waxay isku dayayaan inay ku siiyaan adeegyada ama kuu gudbiyaan barnaamijyada xaaladaada caanka ku ah.

Buug-yarahaan looguma talogalin sida jaheyn dhameystiran oo illaha bulshada. Dhiabayaan dambiga waxaa si xoogan loogu dhiirogelinayaa inay la xiriiraan hay'adaha lagu sheegay buug-yarahaan oo wixii warbixin sharaxaan iyo illaha bulshada.

Sida dhibanaha, waxaad u qalmi kartaa inaad heshid magdhowga dhinaca Dhibanayaasha Ohio ee Barnaamijka Magdhowga Dambiga. Ula xiriiri barnaamijkaan si toos ah wixii warbixin dheeraad ah.

**Rabshada Qoyska:** Rabshada qoysla waxay dhacdaa markii xaaskaaga, lamaanaha wadaagtaan, ama xubin qoyska ama guriga ku hanjabaa erayo iyo/ama hub, isku dayaa inuu sababo, ama kugu sababo waxyeelada jirka (tusaale ahaan: dhufashada, dharbaaxida, feerka, haraantida, qaniinyada ama cagajugleynta).

**Dabagalka:** Dabagalka wuxuu dhacaa markii qofka falalkiisa ku celinta ah kugu sababo murugada maskaxda iyo/ama cabsida waxyeelada jirka (tusaale ahaan: adiga ayay ku raacaan, ku soo waco, kugu hanjabaa, ama si joogta ah kuula soo xiriiraa).

**Dhammaan kuwa kore waxaa loo tixgeliyay dambiyada rabshada. Haddii aad tahay dhibanaha mid ka mid ah kuwaan ama rabshada kale ee dambiyada, iska hubi inaad jir ahaan badbaado tahay oo soo wac 911. Haddii aad dhaawacneyd, raadi gargaarka caafimaad.**

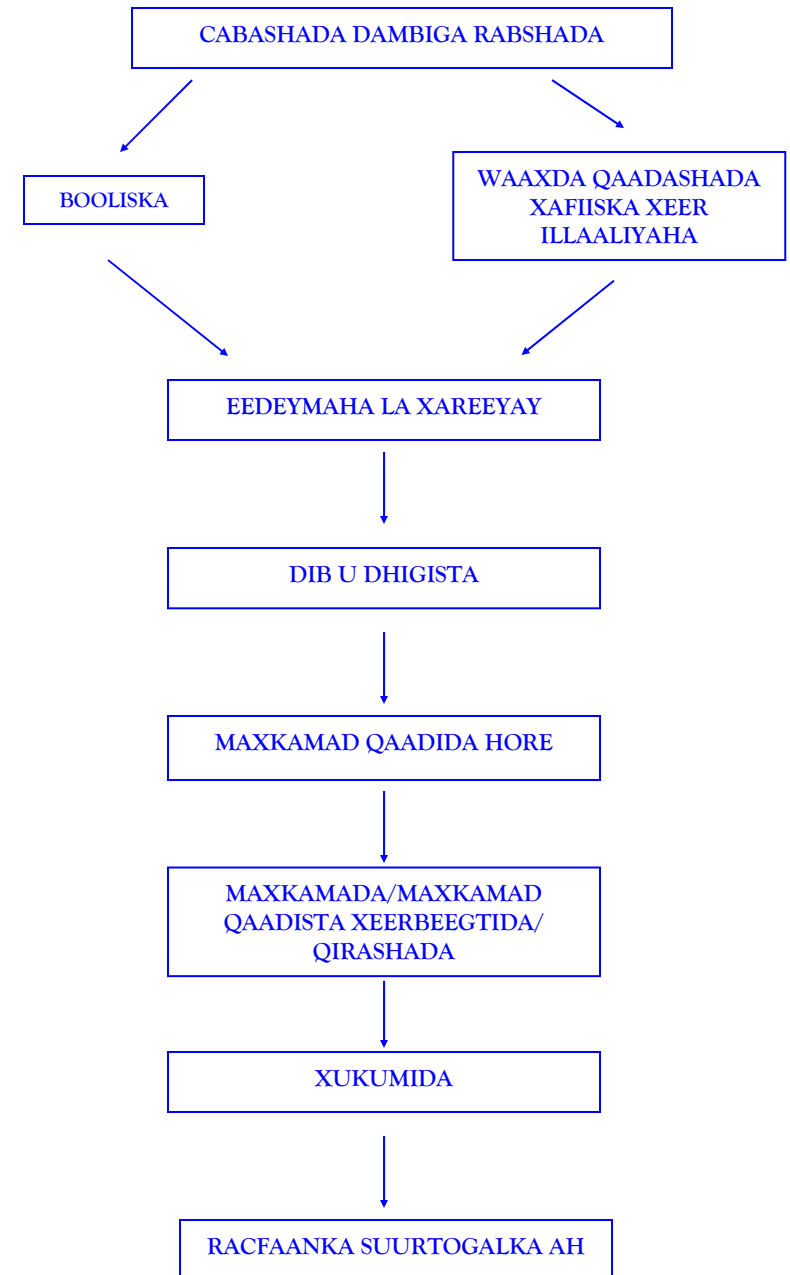

### 5. Racfaanka

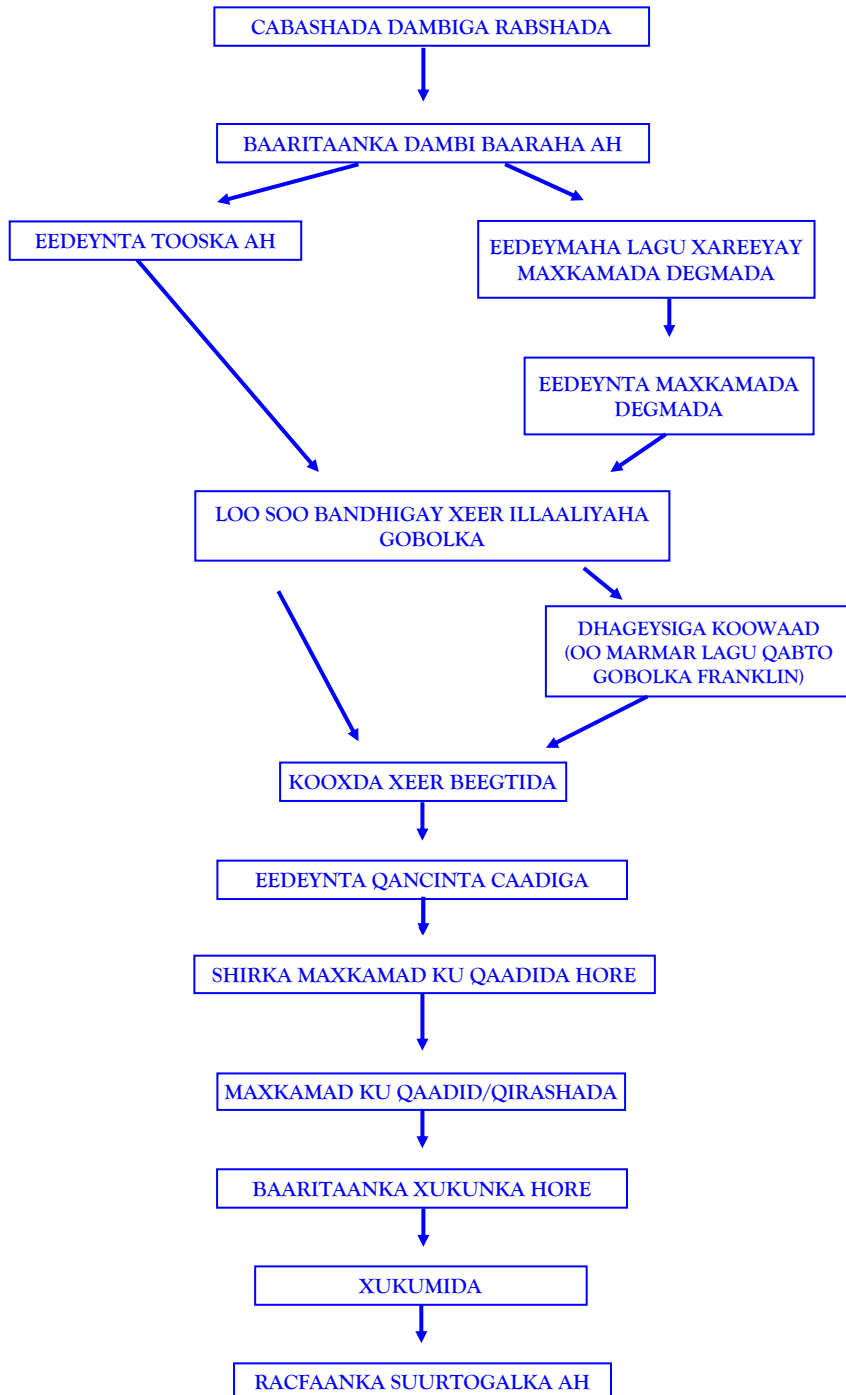

### 4. Maxkamad Qaadida

- Dacwada waxay aadi kartaa maxkamad qaadis halka xeer beegtida ama garsoore, dhageysiga dhammaan cadeymaha kadib, go'aansadaa haddii eedeysanaha uu yahay dambiilaha eedeymaha ama uusan aheyn.
- Dhibanaha waa inuu guud ahaan ku cadeeyaa maxkamad qaadista.
- Dhibanaha looma baahno inii cadeeyo haddii heshiiska qirashada la gaaro. Dhibanaha waxaa la soo ogeysiinayaa heshiiska qirashada iyo heshiisyada.
- Dhibanaha wuxuu xaq u leeyahay inuu joogo inta lagu jiro qirashada oo wuxuu ku sameynayaa Bayaanka Saameynta Dhibanaha maxkamada.

**FIIRO GAAR AH:** Waxaa jirayo inay u badan tahay inay jiraan taariqaha la dajiyay maxkamad qaadida. Sii wadista aad ayay caadi u tahay, oo kuma ahan tilmaamo kartida ama muhiimada dacwada. Inta badan, taariiqda maxkamad qaadista waxay u soconeysaa ujeedooyin jadwal ah.

### 5. Baaritaanka Xukunka hore (P.S.I.)

### 6. Xukumida

- Garsooraha ayaa go'aansanayo ciqabta lagu soo rogayo eedeysanaha. Tani waxay ku kala duwanaan kartaa tijaabo iyo/ama ganaaxa waqtiga xabsiga, waxay ku xirantahay dambiga iyo xaqiiqaha kale.

### 7. Racfaanka

- Haddii eedeysanaha lagu helo dambiga, eedeysanaha iyo qareenkooda way ka racfaan qaadan karaan go'aanka iyo/ama jumlada maxkamada.

Adiga kuuma taalo go'aansiga haddii eedeymaha laga laabto ama la kala diro. Waxaa jiro dacwado badan ee qolka maxkamada maalin walba. Fadlan u diyaar garow inaad sugtid. Waxaad halkaan joogi kartaa dhoor saacadood, marka ugu diyaargarow sida waafaqsan (looguma talin inaad ku baakintid miitarka, sida laga yaabo in tikid lagu siiyo). Keenista qof ku taageero ama wax la aqriyo waa afkaar wanaagsan. Meel badbaado ah ee lagu sugo waa lagu siinayaa.

Damaanada aqoonsanshada/ Ka muuqqashada Aan la hubin (ROR) – waxay u ogolaataa eedeysanaha inuu kaga baxo xabsiga saxiixooda.

Damaanada Ka muuqqashada – eedeysanaha waa inuu siiyaa maxkamada boqolkiiba 10% ee lacagta damaanada iyo qidmada maxkamada ka hor inta aan la siideyn.

Kaashka/Damaanada Masuuliyada – eedeysanaha waa inay bixiyaan tirada damaanada oo dhan oo kaash ahaan ama kireysta damaanada damiintaha (qidmooyinka aan la soo celin karin ee damiintaha waa 10% ee damaanada oo dhan).

**Cabashada:** Bayaanka dhaarta rasmiga ee dambiga ee siiyaa sharciga sida waafaqsan kaas oo eedeysanaha la xiray.

**Joogtada ama Joogteeyay:** Daahitaanka dhageysiga maxkamada ee maalin kale. (e.g. “Dacwada waa la joogteynayaa”).

**Maxkamada (ama Bench) Maxkamad qaadida:** Maxkamad qaadida ka hor maxkamad, ma ahan xeer beegtida.

**Eedeysanaha/Dambiilaha:** Maadada eedeeynta dambiga.

**Qareenka Difaaca:** Qareenka la kireystay ama loo magacaabay wakiilka eedeysanaha (wuxuu noqon karaa midkood bulshada ama gaar ah).

**Cadeynta:** Wax walba aad ku aragtid maxkamada si ay u taageerto dacwada. Waxaa lagu dari karaa marqaatida oo dhibanaha, eedeysanaha ama marqaatida kale, waraaqaha, sawirada, sheeyada dharka, hubka, iyo booliska ama diiwaanada caafimaadka.

**Kooxda xeerbeegtida:** Kooxda dadka tixgeliyaa dacwadaha loo soo bandhigay eedeeynta dambiga. Dacwadaha waa qarsoodi oo u dhow bulshada.

**Eedeeynta:** eedeemaha dambiga weyn ee rasmiga ah ee soo celiyeen Kooxda Xeer beegtida. Waxay noqon kartaa hal ama eedeymo ka badan – eedeeyn walba waxaa loo yaqaan ‘xisaabinta’.

**Maxkamad ku qaadida:** Halka eedeysanaha u qaado dacwadooda dhageysiga ka hor xubnaha xeer beegtida ama garsooraha.

**Bayaanka Saameynta Dhibanaha:** Bayaanka qoran ama iyo/ ama hadalka ee ka yimid dhibanaha dambiga, oo erayadooda gaarka ah, ee ku saabsan sida dambiga u sameeyeyay iyaga.

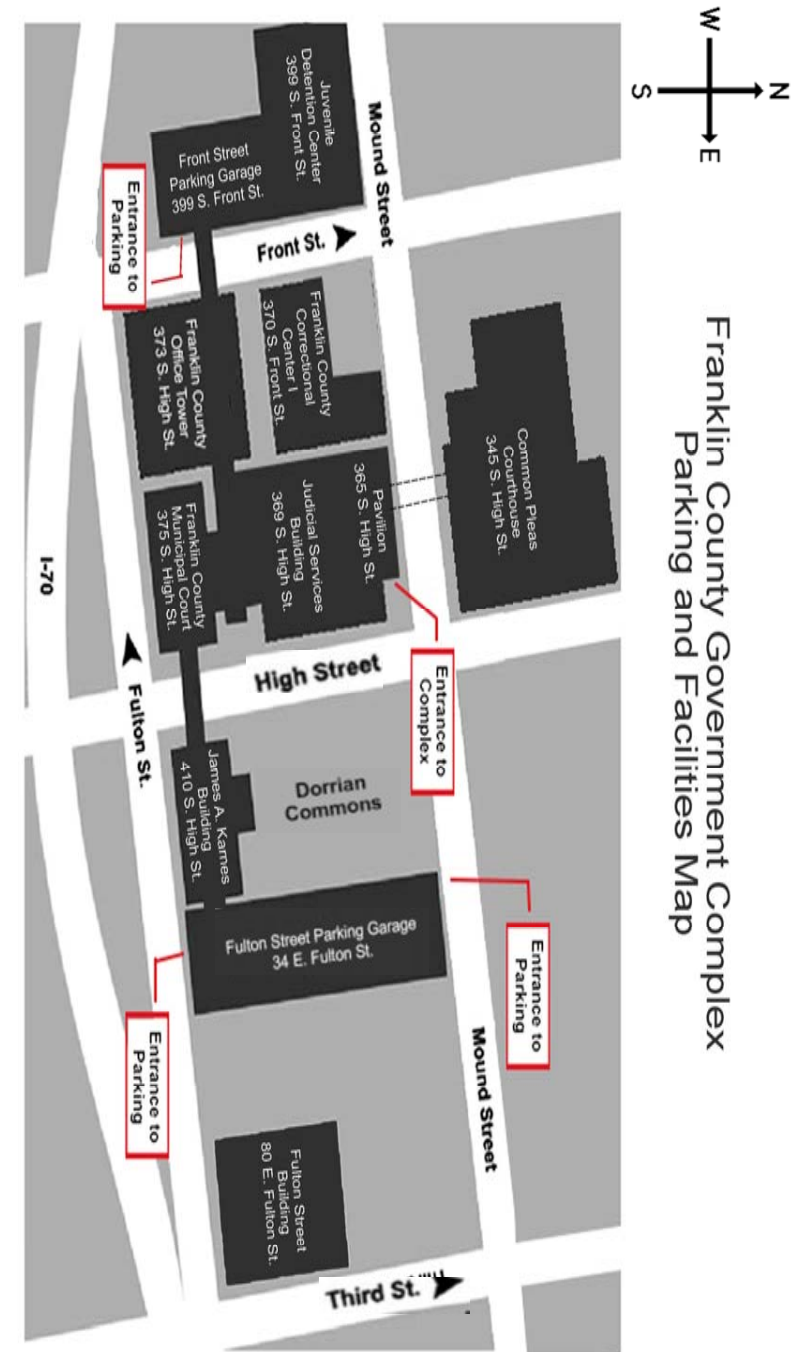

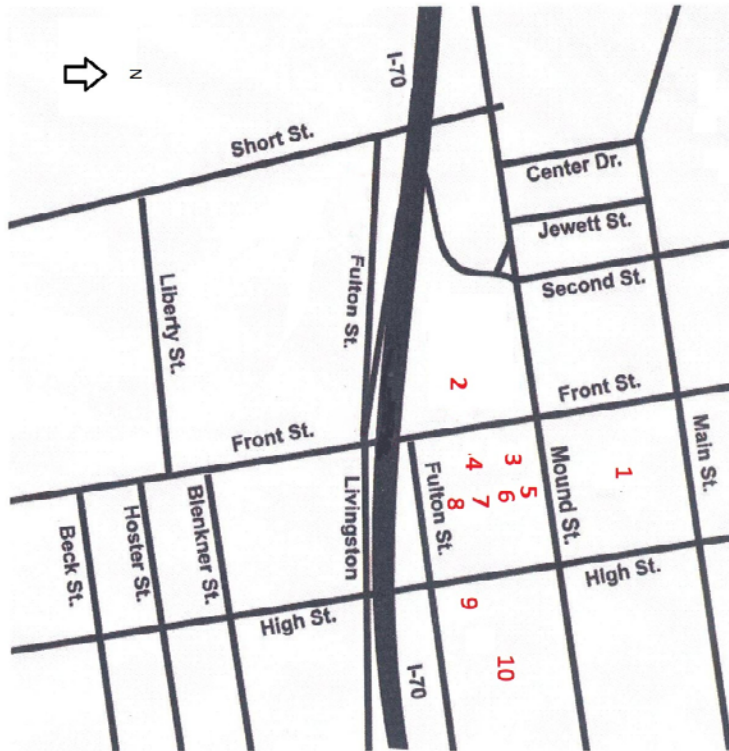
